


Figure 1 Forward Current vs. Forward Voltage




Figure 2 Relative Forward Current vs.




Figure 3 Relative Forward Voltage vs.
Ambient Temperature




Figure 4 Relative Luminous Intensity vs. Forward Voltage




Figure 5 Rel. Luminous Intensity vs. Ambient Temperature




Figure 6 Relative Luminous Intensity vs. Wavelength




Figure 7 Rel. Luminous Intensity vs. Angular Displacement




