
Description


The complementary NPN is the 2STR1215.



Figure 2. Collector-emitter saturation voltage







Figure 3. Base-emitter saturation voltage

Figure 4. Resistive load switching time








Figure 5. Resistive load switching time

Figure 6. Capacitance





Figure 7. Resistive load switching test circuit




